**Three Voting (3) Options**

1. **Mail-In Ballot:** Voter will complete and place the completed ballot into a stamped envelope. Mail to LAPOA, P.O. Box 479, Waleska, GA. 30183. **Envelope must be postmarked by October 19, 2020.**

2. **Email Voted Ballot: (email ballot must be received by 11:59 p.m. October 19, 2020).**

- A. Download ballot, Save the ballot to your device, Choose File/Save As. **DO NOT Save file in your name use a generic name instead.**
- B. Open the document on your device once saved, Mark your selections on this ballot, Save the ballot once completed in a .pdf format.
- C. Open your email, attach this ballot and email to: [LAPOAGAVOTE@gmail.com](mailto:LAPOAGAVOTE@gmail.com)
- D. You will receive an auto generated confirmation email. If you do not see it please check your **SPAM** file.

3. **In Person Voting:** Voter will have the choice of voting in person at the Annual Meeting in October.
